Notice of Intent – Stormwater General Permit for Construction Activity for Facilities Improvement #2. This permit is required to manage stormwater (erosion and sedimentation control) during construction. Jack Dodson prepared the Storm Water

Pollution Prevention Plan (SWPPP) and included details on the contract drawings for erosion and sedimentation control. On the behalf of the Village, Dodson implement the plan and require compliance from contractors at the site during construction. The Owner (Village) must acknowledge there is a requirement to manage storm water during construction. A form is attached for Deputy Mayor Sullivan to sign. Jack attached the certification form that he signed and a copy of the Notice of Intent. The permit includes an annual fee of \$110 that will be invoiced directly to the Village by NYSDEC each year for the next three years. The NYSDEC will issue an invoice for a one time initial authorization fee for each acre disturbed and each new impervious acre created. This invoice (estimated fee \$2,250) will be sent once NYSDEC approves a permit.
