Pat Goodenow reviewed with the board some changes and considerations that the Sylvan Verona Beach Resort Association would like the Village Board to consider along with a revised proposal on vendors and asked Village for support of \$10,000 or higher.

The Mayor has concerns about giving the \$10,000 and asked each Trustee for their input on the support to the SVBRA

Trustee Daily need projections to see path of direction, important village take part in growing and is for ear marking funds of \$10,000 not sure same every year

Trustee Shaughnessy working on budget now should keep \$10,000 lowered taxes for last 6 years mentioned raise taxes, doesn't bother me to raise taxes.

Trustee Clements feels it would be detrimental if we don't contribute

Trustee Sullivan hard to look at SVBRA after 1 year hope Town of Vienna can help and he would like to get through budget before committing would like to support.
